What is the GI Bill?

- Federal effort to provide financial and social benefits to World War II veterans after they returned home (1944)
- There have been several iterations of the bill since its inception, and today it provides education benefits to active service members and honorably discharged veterans
- These benefits have been extended to vocational and technical training programs
- Other military benefits, such as the Yellow Ribbon Program, are available for what the GI Bill does not cover
- Veterans can elect to have these benefits transferred to their immediate family member (spouse and children) while on active duty



GI Bill Programs

- Post-9/11 GI Bill
- Active Duty Montgomery GI Bill
- Reserve and Guard Montgomery GI Bill
- Vocational Rehabilitation and Education Program



Training Available

- Vocational/Technical Training including non-college degree programs
- College degree programs including Associate, Bachelor, and advanced degree programs
- On-the-job/Apprenticeship Training
- Licensing & Certification Reimbursement
- National Testing Programs such as SAT, CLEP, AP, etc.
- Flight Training
- Correspondence Training
- Work-study programs
- Tuition Assistance Top-Up
- Tutorial Assistance

How to Apply

Step 1: Contact your VA State Approving Agency: http://www.nasaa-vetseducation.com

Step 2: Develop a course catalog that addresses required information

Step 3: Submit to State Approving Agency using appropriate approval packet



Refer to Handout

- Items to include with your application
- Catalog must include
 - Policies and Tuition/Refund Information
 - Grading system
 - Minimum grades considered satisfactory
 - Conditions for interruption for unsatisfactory grades or progress
 - A description of the probationary period
 - Remedial courses offered
 - Conditions of reentrance
 - How records are maintained
 - Standards of conduct
 - Attendance standards



The Small Print

- Suitable Agricultural Employment
- Veteran to Civilian ratio
- Course must have been conducted at least 2 years before approval
- Fees cannot be more for veterans
 - Sliding scale?
